He noted that plaintiffs had attempted to plead claims against the Metra defendants but that they were not named as defendants by the Metra defendants. Addressing the indemnification claims, he held that Metra had been determined by the trier of fact not to be liable for any of the claimed injuries. For that reason, plaintiffs had failed to state a claim for which relief could be granted, as they had not alleged any facts demonstrating that any of their claims were based in fact on Metra's conduct. Reasoning that Metra could not be liable to plaintiffs unless plaintiffs could demonstrate that Metra had tortiously caused injury to plaintiffs, Justice Hoffman found that an examination of the plaintiffs' underlying claims compelled that conclusion. In another case, Wexford v. Union Pacific R.R. Co., 115 Ill.App.3d 561, 71 Ill.Dec. 186, 450 N.E.2d 1354 (1983), a plaintiff who suffered injuries in a head-on collision between a railroad and a tractor-trailer sought to hold Metra liable under the LOCA. According to Wexford, the railroad had offered him transportation on Metra without informing him that he would be required to pay a special Union Pacific surcharge to Metra. The court determined that the decision to provide Metra service to Wexford could not form the basis of liability under LOCA. While these cases are factually dissimilar from the one before us, they do suggest that the decision to provide Metra service to persons injured on Metra property is within the control of the Metro defendants, and not *968 that Metra is a common carrier for the sole purpose of providing Metra's railroad service to its riders. This, in turn, suggests that an employee of Metra would not be "engaged in the transportation of passengers or property for compensation" as defined by the Act.
